# Minutes and Matters Arising

Minutes of the meeting held on 19<sup>th</sup> February 2018 were approved as a correct record and signed by the Chairman.

**Defibrillator.**. Cllr.G.Brett Reynolds advised that the type of defibrillator most suitable for our community would cost £2182.00. This sum includes installation, training, all the necessary replacements as and when needed etc. It was agreed that we should proceed with the purchase and an order has been placed with the Community Heartbeat Trust.

**General Data Protection Regulations.** It was agreed that as the Parish Council holds only the personal details of our Parish Councillors and very little else, the Clerk would be appointed the Data Protection Officer and be held responsible for their safe keeping. These regulations come into force at the end of May and we need to register with the ICO (Information Commissioners Office) as a Data Processor and pay a fee of £35 per annum.

## Finance/Audit

The Clerk presented the 2017/18 Audit carried out by Mr.Graham Able for approval by the Councillors before signing by the Chairman and Clerk and sending to the new External Auditors, PKF Littlejohn. A copy of the Income and Expenditure Statement was given to each Councillor.
