Minutes and Matters Arising

Minutes of the meeting held on 14th May 2018 were approved as a correct record and signed by the Chairman.

Defibrillator. Cllr.G.Brett Reynolds advised that the defibrillator had been placed on the side of the Village Hall close to the door and was ready for use and that he would organise a demonstration to volunteer first responders.

Right of Way across land close to Water Hall. Cllr.J.Savoury reported that she was attempting to make contact with former residents of the village regarding their use of the footpath across the land but was finding it rather difficult, she would however keep trying.

Meeting with Highways Engineer. The Chairman reported that he met with the Highways Engineer to discuss concerns raised by village residents with regard to the speed of vehicles approaching the road junctions at the Copys Green end of the village and was awaiting his report.
