Minutes and Matters Arising

Elections

As the Wighton May 2nd Parish Council elections were uncontested the Councillors completed new Acceptance of Office forms to be retained by the Clerk and Register of Parish Members' Interests forms to be sent to North Norfolk District Council.

It was also necessary to elect the Chairman and Cllr.J.Harrison proposed and Cllr.T.Guillory seconded that Cllr.S.Temple be re-elected as Chairman. Cllr. J. Harrison to continue as Vice Chairman.

Planning

Application No.PF/19/0484 - Change of use of agricultural land/buildings to events venue and camp site.Potters Farm, Crabbe Road, Wighton. Following a site meeting with the applicant it was decided that if all the items discussed and promises made relating to noise, access etc. were strictly adhered to, we had no objection to the project and North Norfolk District Planning Department advised accordingly.
